Conditions for Retention of Membership after Termination of Service in the Permanent Defence Forces

- 62. Notwithstanding the provisions of any other Rules a member whose service in the Permanent Defence Forces has been terminated may retain membership of the Society subject to the following conditions:
 - (a) Spouse must have completed 10 years spouse membership.
 - (b) Membership may be retained only for whichever of the following periods is the lesser:
 - (1) the period between the date on which membership is due to cease and the member's seventieth birthday.
 - (2) the period of years equal to the nearest whole number resulting from the division of the total amount due to the member pursuant to Rules 17 and 17A by the mount of the annual subscription, to nearest Euro, pursuant to Rule 14 subject to a maximum period of 22 years.
 - (c) During the appropriate period referred to at Para (b) of this rule he/she will:
 - (1) NOT be liable to pay further subscriptions pursuant to Rules 14 and 15,
 - (2) NOT be eligible for further bonus pursuant to the provisions of Rule 17A,
 - (3) NOT be entitled to the refund of his/her subscriptions pursuant to Rules 17 and 17A until the period of retention of membership terminates,
 - (4) be entitled to such benefits as are applicable to other members pursuant to Rules 18 and 18A on the date from which he/she was permitted to retain membership under this rule.
 - (d) A member who has been allowed to retain membership may apply at any time for such membership to be terminated. Membership thus terminated shall not subsequently be renewed. (Note: In this case subscriptions will be refunded).
 - (e) An application for retention of membership shall not be valid unless it is forwarded so as to reach the Secretary, 28 days prior to the termination of the member's service in the Permanent Defence Force.
 - (f) Each application for retention of membership shall be placed before a meeting of the committee for authorisation.
 - (g) The Committee shall in its absolute discretion decide whether or NOT to authorise any application for retention of membership.
 - (h) The Secretary shall issue a certificate to that effect to each member whose retention of membership has been authorised.
